A] Services Provided

Shantani wants to file a patent regarding 'target identification of drug' IPFACE provided them a service of patentability assessment. The assessment report helped them apply for seed funding at Venture Center.

Provisional application was drafted for Hypro engineers for 'technique for CO2 liquefaction and CO2 evaporation for maximum energy saving and recovery'.
